Please review the following information regarding the Period Activity Pay (PAP) process for Spring 2024 for PTF Counselors.

#### PAP Process for Part-time Faculty (PTF) Counselors in Workday

Workload in Banner (SIAASGN) will still need to be entered and continuously updated and accurate. All PAP in Workday must be created, approved, and processed for PTF Counselors as described below:

#### Due Dates

Spring for PTF Counselors: PAPs for 202430 must be entered in Workday and approved by the Chair by COB January 5, 2024. Meeting the January 5, 2024 HRSTM deadline ensures timely processing of the 1<sup>st</sup> Spring pay on January 12, 2024.

#### Reminder about Workload/ESH Limits

Equivalent Semester Hour (ESH): Per the SEIU contract, a part-time faculty member is limited to a total of 11.5 ESH over the course of the Spring semester. The 11.5 ESH limit for Spring will include any ESH assigned during the Winter session.

#### PAP Processing Reminders

- Make sure to enter all changes into SIAASGN FIRST.
- For additional ESH after you have processed the Winter PAPSs, create a new PAP.
- For reduction or cancellation of ESH, use the Faculty Change Form. This form should be completed for all changes (reduction, additions, cancellation, etc.). It needs to be signed by the Chair (PTF) and uploaded to Workday when you update the existing PAP.

#### ESH Rates

As of the first day of the AY 23/24, the ESH rates for PTF are the following amounts:

Lecturer	\$1,460.00
Adjunct I	\$1,580.00
Adjunct II	\$1,690.00
Adjunct II+	\$1,705.00

#### General Reminders

- Please remember and adhere to the stated deadlines.
- The College is closed for Winter Break from December 23, 2023 through January 1, 2024. Please take this into consideration when preparing and submitting all PAP.
- HRSTM will not determine or calculate workload/ESH. We will offer guidance, when necessary.
- Please ensure you are completing all necessary fields in SIAASGN and on the PAP (if you need to complete one).

- Please be advised that non-exempt employees are not allowed to have any PTF jobs, NO exceptions.

### Weekly Service Hours Tool

Please refer to the additional Excel attachment for the weekly service hours tool. This will help you calculate how many hours to input in the Work Hours per Week field when you are creating a PAP in Workday for part-time faculty.

### Verifying which PAPs have been Posted

You have two (2) options to confirm whether the PAPs have been posted in Workday:

- Run the "MC All Period Activity Pay Assignments" report in Workday.
  - You can use whichever filters work best for you. Not all have to be populated. Here are some suggestions:
    - **Supervisory Organization** You can leave it blank or add the name of the manager (make sure to pick the one that says JM).
    - Academic Periods Type in term number, e.g., 202330 for Spring.
    - Period Activity Types You can filter here if you want to just see one type, e.g., PTF Pay.
- Check on the faculty's profile.
  - On their profile, go to Compensation → Current Activity Pay or Historical Activity Pay. If they have multiple jobs, then you will have to go under each position to see all PAPs.
