Subject: **Important Information for Workday Period Activity Pay (PAP) for Fall Semester 2025**

Date: August 18, 2025

Please review the following information regarding the Period Activity Pay (PAP) process for Fall 2025 (Term 202620).

PAP process for Part-time Faculty (PTF) in Workday

Workload in Banner (SIAASGN) will still need to be entered and continuously updated and accurate. All PAP in Workday must be created, approved, and processed for part-time faculty as described below.

Fall Integration for PTF

Here is the process of how the Fall integration will work for instructional workload:

1. Instructional workload in SIAASGN for term 202620 must be entered by **COB August 29, 2025** so we can begin our audits. Make sure you are using **contract type PT for PTF** and **contract type PS for Staff with PTF jobs**. You will still be able to add/change workload after that.
2. We will be sending out Excel audit reports to review info that will be coming over the integration is correct.
3. All final SIAASGN workload you want to come through the integration must be entered by [COB September 08, 2025](#).
4. **The integration will run on Tuesday, September 09, 2025.** This will only pull instructional workload from SIAASGN and create PAPs in Workday.
5. You won't have to calculate the weekly service hours for those coming through the integration.
6. These will be auto approved so the department chairs do not need to approve the ones that come through the integration.
7. Non-Instructional workload will not come through the integration. You will still have to enter these in SIAASGN and then create a PAP in Workday.

8. In order for Instructional Part-time to be paid by September 19, 2025, all manual Period Activity Pays must be completed *AND* approved by the Chair by [COB Thursday, September 11, 2025.](#)
9. In order for Counseling Part-time to be paid by September 05, 2025, all manual Period Activity Pays must be completed *AND* approved by the Chair by [COB Friday, August 29, 2025.](#)

Different part of terms breakdown and pay

There will be four (4) Part of Terms for Fall Semester Term 202620: 1, 2, 3, and 8. Please note the specific Part of Term when entering the applicable PAPs. Using the wrong dates will result in incorrect and/or delayed pay.

Part of Term 1 (15 weeks)*

Begin Date	9/02/2025
End Date	12/21/2025
Total of 9 pays	1 st Pay Date on 9/19/25 9 th and Final Pay Date on 1/09/26

**Non-Instructional Workload (for non counselors) should follow dates for full semester (Part of Term 1).*

Part of Term 2 (7 weeks)

Begin Date	9/02/2025
End Date	10/20/2025
Total of 4 pays	1 st Pay Date on 9/19/25 4 th and Final Pay Date on 10/31/25

Part of Term 3 (7 weeks)

Begin Date	10/29/2025
End Date	12/21/2025
Total of 5 pays	1 st Pay Date on 11/14/25 5 th and Final Pay Date on 1/09/26

Part of Term 8 (13 weeks)

Begin Date	9/15/2025
End Date	12/21/2025
Total of 8 pays	1 st Pay Date on 10/03/25 7 th and Final Pay Date on 1/09/26

Counseling part-time faculty

Since counselors are working the week of 8/25-8/29 the below dates should be used.

PTF Counselors

Begin Date	8/25/2025
End Date	12/19/2025
Total of 9 pays	1 st Pay Date on 9/05/25 9 th and Final Pay Date on 12/26/25

Reminder about Workload/ESH Limits

Per the SEIU contract, a part-time faculty member is limited to a total of 11.5 Equivalent Semester Hour (ESH) over the course of the Fall semester.

PAP Processing Reminders

- Make sure to enter all changes into SIAASGN first.
- For additional ESH after the Fall integration has processed, create a new PAP.
- For reduction or cancellation of ESH, use the Faculty Change Form. This form should be completed for all changes (reduction, additions, cancellation, etc.). It needs to be signed by the Chair (PTF) and uploaded to Workday when you update the existing PAP.

ESH Rates

As of the first day of the AY 25/26, the ESH rates for PTF are the following amounts:

Lecturer	\$1,583.00
Adjunct I	\$1,713.00
Adjunct II	\$1,832.00
Adjunct II+	\$1,850.00

Weekly Service Hours Tool

We have also created a Weekly Service Hours Tool to help you calculate how many hours to input in the Work Hours per Week field when you are creating a PAP in Workday for part-time faculty. Please refer to the additional Excel attachment for the weekly service hours tool.

General Reminders

- Please remember and adhere to the stated deadlines.
- HRSTM will not determine or calculate workload/ESH. We will offer guidance, when necessary.
- Please ensure you are completing all necessary fields in SIAASGN and on the PAP.

- Please make sure that when creating a PAP for Alternate ESH, you are using the Banner-to-Workday Crosswalk Query when it should be charged elsewhere than their default Fund, Cost Center, Program, Discipline, etc.
- ***Please be advised that non-exempt employees are not allowed to teach as PTF members. There will be no exceptions.***
- ***Please make sure that you are adding all Part-time Faculty Assignment Letters and Alternate ESH Request Forms to the PAP or faculty member's document section under Personal in Workday.***
- ****New* If you have any grant alt ESH forms please add them to this MS form ([Share Alternate ESH Forms with OBS/Grant Accounting](#)). This will help keep OBS better informed of alt ESH that is being charged to grants.***

Verifying which PAPs have been Posted

You have two (2) options to confirm whether the PAPs have been posted in Workday.

- Run the “**MC – All Period Activity Pay Assignments**” report in Workday.
 - You can use whichever filters work best for you. Not all have to be populated. Here are some suggestions:
 - **Supervisory Organization** – You can leave it blank or add the name of the manager (make sure to pick the one that says JM).
 - **Academic Periods** – Type in term number, e.g., 202620 for Fall.

- **Period Activity Types** – You can filter here if you want to just see one type, e.g., PTF Pay.
- Check on the faculty member's profile:
 - On their profile, go to **Compensation** → **Current Activity Pay or Historical Activity Pay**. If they have multiple jobs, then you will have to go under each position to see all PAPs.
