

## THE PURPOSE OF ADDENDUM IS TO <u>MAKE CHANGES</u> AND P<u>ROVIDE ANSWERS TO THE REQUEST FOR</u> <u>CLARIFICATIONS</u> TO THE RFP DOCUMENTS.

Item 5-1 Extend the RFP closing date and time from 2:00 p.m. on Feb. 11, 2022 to 2:00 p.m. on February 14, 2022.

Item 5-2 Provide answers to the Request for Clarifications as follows

- (1) Question: Section 002413 requests resumes' of the project manager, superintendent, and quality control manager for the technical proposal submission. Can any of these positions have dual roles?
  - Answer: For a project of this size and scope, a separate person should be assigned to each role.
- (2) Question: Is Alternate 1 needed to be completed within the project schedule as stated in Section 002213?
  - Answer: Yes, add alternate #1 is expected to be completed within the project schedule as stated in section 002213
- (3) Question: Drawing AD1.01 states to clean biological growth from the penthouse masonry façade. Please confirm all 4 sides of the façade need to clean.

Answer: Confirmed, clean all four (4) sides of penthouse façade.

- (4) Question: Are all the roof drains need to be replaced?
  - Answer: Yes, all roof drains should be new and installed into the existing pipe below the roof deck.
- (5) Question: On the lower level, there is at least one RTU unit that will require disconnect lift, remove and replace roof then reset and reconnect this unit. See photo #1a & #1b.
  - Answer: Contractor to include cost of disconnecting, lifting, and replacing unit on new curbs as detailed in the drawings.







- (6) Question: Foundation appears to be sagging which means the unit is set on the roof and not the deck. This would also require disconnect and reconnect after new roof system is in place. See photo #2.
  - Answer: Contractor to include cost of disconnecting, lifting, and replacing unit on new curbs as detailed in the drawings.



- (7) Question: Condenser unit set on Pad set on roof will require disconnect and reconnect when new roof system is in place. See photo #3a & #3b.
  - Answer: Contractor to include cost of disconnecting and replacing unit as detailed in the drawings. Protection as required by the membrane manufacturer for surface bearing units will be required.








- (8) Question: Please verify that the well roof which support the Water tower (cooling tower) structure is not included in the base bid. See photo #4a & #4b.
  - Answer: Confirmed, the roof within the water tower well is not included within the contract. The scope will terminate with the flashing integration over the curb and into the water tower area.







- (9) Question: During the site visit, it was mentioned there are hazmat materials to be abated. Accordant to the hazmat report, no asbestos was found. Please advise.
  - Answer: The asbestos report attached to the RFP confirms that there is no asbestos in the roofing assembly. There is asbestos in the pipe joints of the roof drains which the College will have abated. Additionally, contractors are advised that the College will also perform a separate abatement project inside of the building while the roof replacement is taking place.
- (10)Question: There are notes on drawing AD1.01 indicate to remove and dispose of the existing curbs and equipment, and remove and replace damaged electrical and mechanical pipes and conduits. However, the drawing does not show which curbs and/or equipment to be removed and disposed, nor the damaged electrical and mechanical pipes and conduits to be removed and replaced. Can you provide the quantities/type of curbs/equipment to be removed and disposed, and electrical/mechanical pipes and conduits to be removed and replaced? If no information is available, we suggest an allowance should be established for these unknown items.



Answer: Roof curbs: The note indicating the removal and disposing of curbs is limited to <u>abandoned</u> curbs. In general, roof curbs are intended to remain in place for mechanical units that will not require lifting for the roof replacement to occur. Where lifting of the equipment is required based on other pre-bid questions, the cost of new curbs should be carried by the contractor to properly reinstall the mechanical system. Roof curbs should be considered to be replaced with materials like-in-kind to the existing.

Miscellaneous MEP Piping/Conduit: It is unknown at this time how much damaged miscellaneous MEP piping will be encountered. Therefore, the Price Proposal Form is updated to reflect unit rates with estimated linear footage of the following material:

- 1. Schedule 40 PVC pipe or conduit, up to 4" in diameter.
- 2. Hydronic copper piping with minimum of R-8 exterior grade insulation and aluminum jacketing, up to 5" in diameter
- 3. Metal EMT conduit, up to 3" in diameter

Price Proposal Form is reissued and attached. **Please use Revised Price Proposal** Form for submission. Failure to do so will deem a proposal non-responsive.

All other specifications, terms and conditions remain unchanged.
